

HEDGECHECK LLC PRIVACY STATEMENT

Your privacy is important to HedgeCheck LLC. This privacy statement provides information about the personal information that HedgeCheck LLC collects, and the ways in which HedgeCheck LLC uses that personal information.

Personal information collection

HedgeCheck LLC may collect and use the following kinds of personal information:

In addition to the disclosures reasonably necessary for the purposes identified elsewhere above, HedgeCheck LLC may disclose your personal information to the extent that it is required to do so by law, in connection with any legal proceedings or prospective legal proceedings, and in order to establish, exercise or defend its legal rights.

HedgeCheck LLC will take reasonable technical and organisational precautions to prevent the loss, misuse or alteration of your personal information and that of the subjects under review. Precautions include physical custody procedures and electronic measures such as passwords and/or encryption.
